# Update on PULSE

HIETexas Service	Status		
Patient Unified Lookup System for Emergencies (PULSE)	Contract amendment under development.		

### Contract amendment under way:

- THSA will receive IAPD 90/10 funds to build infrastructure for the PULSE system.
- THSA procured a vendor, Audacious Inquiry, to assist with implementing the PULSE system.

- Build minimum viable product for use in remainder of 2020 hurricane season
- Conduct system upgrades in advance of the 2021 hurricane season
- Build PULSE "Emergency Census" a family reunification tool



# **Update on Query Services**

HIETexas Service	Status		
Query-based, bi-directional health information exchange	Adding query functionality to EDEN in SFY20 and SFY21.		

### Next phase of EDEN project:

 THSA is adding C-CDA query-based functionality as part of the next phase of the EDEN project.

- Build query-based functionality this month (Aug. 2020) under HHSC contract amendment.
- Collaborate with stakeholders to develop additional query-based use cases (e.g., HIE-to-HIE, etc.).



# Update on Public Health Reporting

HIETexas Service	Status				
Public Health Reporting	Have received interest from stakeholders to develop this service. Applying for ONC grant.				

### Discussions to date:

- Public health reporting has always been on the roadmap for HIETexas, and is a component of the State HIE Plan.
- THSA is discussing a path forward with DSHS and local HIEs.
- There has been interest since our last meeting in how the HIETexas
  infrastructure (EDEN, PULSE, and/or both) could be used for public health
  reporting use cases, such as COVID-19 response.

- Figure out how to pay for the system (more details on next slide).
- Discuss next steps with DSHS and private-sector stakeholders.

### Overview:

- Released on August 12, 2020
- Cooperative agreement to connect public health with HIE services
- \$2.5M for up to five (5) cooperative agreements over 2 years

### Discussions to date:

- Have discussed with our vendor, Audacious Inquiry, as well as HASA (the first HIE connected to HIETexas)
- Held a discussion with DSHS on Monday, August 17, 2020

- Develop application and collect letters of support
- Submit application on or before September 1, 2020
- Award anticipated by September 30, 2020
