• Current status:

- Live and in production now.
- SFY 2020 build-out activates completed on time.
- Establishes basic "push" HIETexas infrastructure to send data to authorized subscribers.
- Data is transmitted from Local HIEs (HASA is live) and other data sources to HIETexas and then to authorized subscribers.

• Next steps:

- Adding additional capacity for increased number of connections.
- Adding query capability.
- The result will be more data is available to authorized subscribers for covered persons.
- HIETexas is leveraging the eHealth Exchange to obtain these additional C-CDA documents.

- Live and ready for use now.
- Deployment was completed on schedule.

• Next steps:

- This significant update adds additional capacity and end-user features.
- PULSE EE is scheduled to deployed in a test environment in Nov./Dec. 2020.
- Scheduled to be deployed for production use in Dec. 2020/Jan. 2021.
- Additional features scheduled to be built and available before 2021 hurricane season begins.

Update on Public Health Reporting

HIETexas Service	Status
Public Health Reporting	THSA, in partnership with Ai and HASA, was recently awarded the ONC STAR HIE cooperative agreement.

- Purpose
 - Allow automated collection of data from Texas hospitals regarding critical capacity metrics (open ICU beds, ventilators, etc.). Based on standards.

• Progress to date:

- Grant awarded! THSA is the awardee. HASA and Ai are subcontractors.
- Currently in planning stage to develop governance. Will soon release call for participation in project advisory groups.
- Conducting weekly meetings with ONC staff.
- Next steps:
 - Detailed project work plan is being formulated.
 - Submitted HIMSS presentation proposal.
 - Press release is in process.
