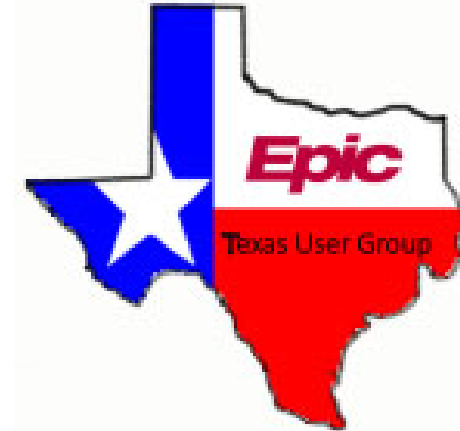

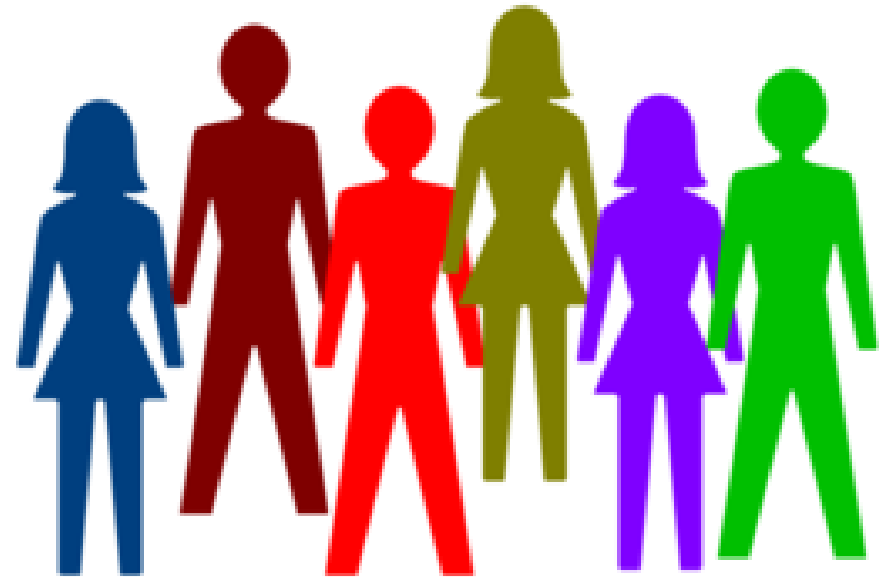
Texas Interoperability Symposium

ANTITRUST POLICY STATEMENT

“The Texas Health Services Authority (THSA) was created by the Texas Legislature to establish statewide health information exchange capabilities.”

The members of this meeting will not play any role in the competitive decisions among HIE competitors, nor will they in any way restrict competition of HIE in Texas. Rather, this meeting serves as a forum for a free and open discussion of diverse opinions in how to implement HIE in Texas.

The members of this meeting recognize the possibility that this meeting could be viewed as a forum for anti-competitive conduct. Therefore, this policy statement clearly and unambiguously supports strict compliance with all state and federal antitrust laws.
