What CMS programs require electronic case reporting?

As of Jan. 1, 2022, **eCR** is required by the Centers for Medicare and Medicaid Services' Promoting Interoperability Program (PIP) for eligible hospitals and critical access hospitals and the Merit-Based Incentive Payment System (MIPS) Promoting Interoperability Performance Category for eligible clinicians.

Who sets the standards for TEFCA? The Office of the National Coordinator for Health Information Technology (ONC) and the Recognized Coordinating Entity (RCE) govern the Trusted Exchange Framework and Common Agreement (TEFCA). The RCE selects the Qualified Health Information Networks (QHINs), the networks of organizations that share health data.
